Iron(III) nitrate (7782-61-8) 8%, Nitric acid (7697-37-2) 6%, and Water (7732-18-5) 86%.

Synonyms: Ferric nitrate solution

---

Pale yellow to colorless acidic aqueous solution. Slight nitric acid odor.

Corrosive to body tissues by contact and inhalation. Avoid contact with skin, eyes, and mucous membranes.
